E. Crash Reduction Factors

As noted at prior Committee meetings, crash reduction data is used to calculate safety improvement scores for proposed STP projects. The data has come in the past from a CMAP table augmented with external data. As proposed, the CMAP table has been revised to proactively include data from those external sources. This will expedite scoring and provide applicants with clearer information on the value of mitigations under contemplation. Use of the revised table is proposed for the CFP.
