#### D. <u>DuPage Council Methodology Guidance</u>

The DuPage Council's Roadway Projects Methodology outlined in the DMMC STP Manual indicates that Pavement Condition will be scored using CMAP's Pavement Condition Index (PCI) data. CMAP issued specific guidance to use IDOT's Condition Rating Survey (CRS) data as it is from 2022 whereas CMAP's PCI data is from 2018. An email was sent outlining how the Council will score Pavement Condition in the current Call for Projects using IDOT CRS data.

The CMAP Board and MPO Policy Committee gave final approval to the proposed FFY 2024-2028 STP-Shared Fund (STP-SF), Congestion Mitigation and Air Quality Improvement Program (CMAQ), Carbon Reduction Program (CRP), and local Transportation Alternatives Program (TAP-L) for inclusion in the TIP.
