C. Six-Month Extension Requests

CMAP Active Program Management guidelines require programmed projects to be fully obligated by the end of that Federal Fiscal Year (FFY), September 30. Projects unable to meet the obligation deadline can request one, six-month extension to the April 2025 IDOT letting. Three projects have requested six-month extensions. D. Downers Grove Cost Increase Request – Main Street Improvements

Downers Grove has submitted the attached cost increase request for its Main Street Improvements project for a total of \$196,979.
