IV. COMMITTEE DISCUSSION

A. STP Shared Fund Subregional Priority Presentations and Vote

May explained that DuPage County, Westmont, Elmhurst, Glen Ellyn, and Pace would each be given 10 minutes to present to the Committee. Following the presentations, the Committee will vote on how to allocate the DuPage subregional priority points.

Before the presentations, May provided an overview of the voting process. He noted a detailed email explaining the process was sent to members the day before the meeting. He explained that each municipality and DuPage County may cast one vote consisting of 5 points to allocate to one or multiple projects. Following the presentations, members will enter the number of points they wish to allocate to each project in the points column of their ballots. After members vote, staff will collect the in-person paper ballots and members attending remotely are to reply to the email sent by staff the day before to submit their ballots virtually. Scores received from remote voters will be combined with those received from in-person voters and tabulated by staff. In the event of a tie score, the names of the sponsors will be placed in a bucket with the winner publicly drawn at the meeting. Results will be announced

before the meeting adjourns and all scoring will be final. May asked the Committee if they had any concerns related to the voting process and no concerns were raised.

Melisa Ribikawskis, Senior Transportation Planner at DuPage County, gave a presentation on the County's 31st Street Multi Use Path project.

Amy Ries, Public Works Director at the Village of Westmont, gave a presentation on the Village's Metra Station Grade Separated Pedestrian Crossing project.

Ted Sianis, City Engineer at the City of Elmhurst, gave a presentation on the City's Bicycle and Pedestrian Overpass over IL-83.

Rich Daubert, Professional Engineer at the Village of Glen Ellyn, gave a presentation on the Village's Metra Station/Multimodal Access Improvements project.

Taqhi Mohammed, Supervisor for ITS and Transportation Engineering at Pace, gave a presentation on Pace's Transit Signal Priority project.

The Committee voted to allocate the DuPage subregional priority points as follows:

- Elmhurst – Bicycle and Pedestrian Overpass over IL-83: 5 Points
- Glen Ellyn – Metra Station/Multimodal Access Improvements: 4 Points
- Westmont – Metra Station Grade Separated Pedestrian Crossing: 3 Points
- DuPage County – 31<sup>st</sup> Street Multi-Use Path: 2 Points
- Pace – IL-83 Transit Signal Priority: 1 Point

A motion was made by Goldsmith, seconded by May, to recommend the Committee's allocation of points to the Board of Directors for final approval. The motion carried.
