A. FY 2026 CMAP Planning Liaison (PL) Agreement

The FY 2026 CMAP Intergovernmental Agreement for MPO activities outlines the scope of services and budget for the DMMC PL and transportation program. The budget is \$267,235, with a federal match of 80% and a local match of 20%. Federal funding to DMMC will be \$213,788, reflecting a 2% increase from FY 2025. The Committee is asked to recommend approval of the attached agreement.

B. Wood Dale Cost Change Request – Mittel Drive Resurfacing

Wood Dale has submitted the attached cost change request for its Mittel Drive Resurfacing project. Due to shortened project limits, the total construction and construction engineering costs decreased from \$1,948,900 to \$1,188,000. The project was initially awarded \$974,450 with a federal match of 50%. The Committee is asked to consider a revised federal match of 70%, which would result in federal participation of \$831,600.
